Receive your booking instructions

Decide whether the contract and invoice will be in the name of the organisation or an individual participant. Check our [terms and conditions](#).

Finalise your contract

Once you receive the booking instructions, you have 7 days to provide all required information.

Doublecheck with your organisation any special invoice requirements (otherwise we will issue the standard invoice once we receive your payments)

Once we receive the required information, we'll issue your contract agreement:

- For organisations: a document to be signed by the legal representative.
- For individual bookings: an enrolment form.

Complete and return your contract within 7 days of issue. The contract becomes *effective* when signed by your legal representative and returned to us (for organisations) or when the enrolment form is submitted (for individual bookings).

Secure your spot

We will send you the sales order and the invitation to the kick-off meeting.

Pay the **30% deposit** within 7 days of the sales order date (**due 12 weeks before arrival**).

- For organisations: complete the participant enrolment forms (**due 8 weeks before arrival**).

Before you arrive

You and/or your participants attend the kick-off meeting at least 6 weeks before arrival to clarify learning needs, align expectations, and define the key elements of your programme.

You will receive Info package (programme, venue, accommodation, activities) at least 4 weeks before arrival.

Final payment

Pay the remaining **70% balance** (**due 4 weeks before arrival**).
